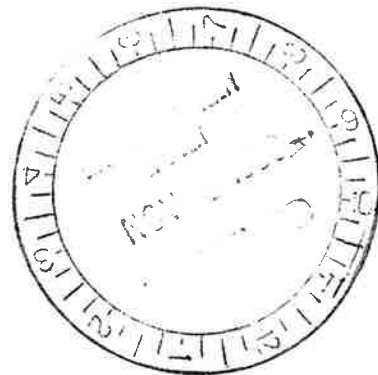

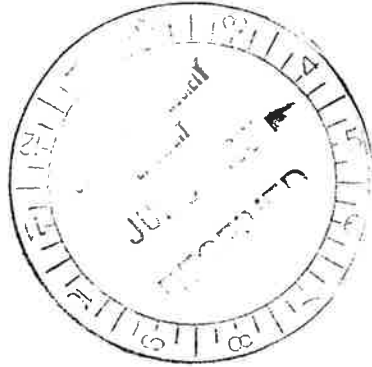

Re: H.O.M.E. Program

Please find enclosed two copies of the legal agreement for the above program now funded under the Child and Family Services Act. Completion of these documents will effectively transfer the program from the Brant Children's Aid Society to the Six Nations Council.
